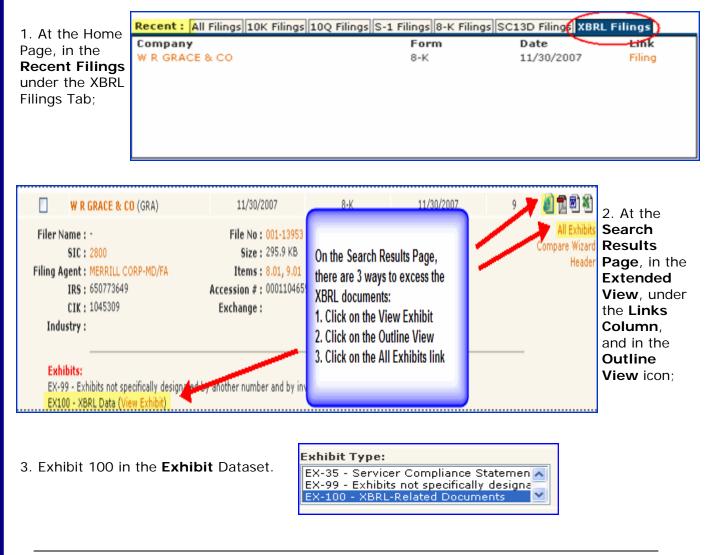


XBRL: INTERACTIVE DATA VIEW

XBRL (eXtensible Business Reporting Language) is a new way for companies to modernize their reported financials in their SEC filings. This tool could be required for all companies, beginning April 13th, 2009, to adopt the use of XBRL when filing documents. During 2009 companies that have revenues greater than \$5 billion dollars will be required to use this new language. All other public companies that file with the SEC will be phased in by 2010 and 2011. XBRL can be described as a data tag or bar-code. The language helps users to quickly retrieve data points from a company's financial statement. When XBRL is used in connection with a spreadsheet, it allows users to calculate figures reported and create "apples-to-apples" comparisons.
