Company Intelligence Service

Profiling Multinationals Across Emerging Markets

The **Company Intelligence Service** is a fully researched database which links the global subsidiary networks of the world's top 750 multinational companies located across Asia, Latin America, Europe, the Middle East and Africa. The database comprises over 120,000 senior executives at 55,000 unique company sites; up-to-date listings of all major foreign direct investments and projects involving multinational companies, and daily news and analyses covering multinational company developments.

The Company Intelligence Service is used by sales and marketing teams for business development, and by corporate analysts and strategists for benchmarking and competitive analysis. The end-user relies on data accuracy, which is why company profiles are systematically researched each year at source, by a combination of web, email and telephone validation. In addition, company updates and new company profiles and executive appointments are added to the database daily through continuous desk research.

Principal Contents

Company Profiles Each company profile includes full contact information, senior executives and decision-makers and their titles, date of company registration in local market, US\$ annual sales, number of employees, full business activity, industry classification and NAIC coding, nationality, ownership structure and legal status, and fully structured links to regional and head offices.

Multinational Company Networks Features multinational company homepages listing global site networks for each company, links to competitor and peer group networks, and daily company and industry news coverage. Includes competitive landscapes ranking peer group companies by estimated annual sales, employee size and registration date, both at country and regional levels.
